

KNOW ALL MEN BY THESE PRESENTS, that Jack T. Pendergraph and Sandra J. Pendergraph

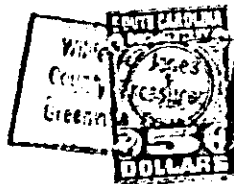
In consideration of -----TWO THOUSAND SIXTEEN and 68/100-----(\$2,016.68)----- Dollars,
