Reference is hereby made to said plat for a more particular description.

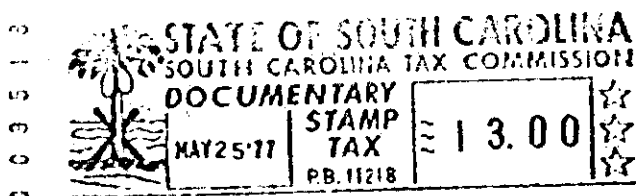
This conveyance is made subject to the restrictive and protective covenants affecting
