KNOW ALL MEN BY THESE PRESENTS, that I, RUTH M. PATRICK,

in consideration of One Dollar and partition of property ----- (\$1.00)---Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WM. R. TIMMONS, JR., His Heirs and Assigns forever; all my right, title and interest in and to the following described property, the same being a one-half undivided interest with the Grantee herein owning the other one-half undivided interest.

ALL that certain piece, parcel or lot of land in Austin Township, County of Greenville, State of South Carolina, and having according to a survey by W. R. Williams, Jr., the following metes and bounds, to wit:

BEGINNING at a point on the Western side of Ridge Road at the joint corner of the property herein being conveyed and property now or formerly belonging to Wm. R. Timmons, Jr. and W. T. Patrick (said point being approximately 525.4 feet South of the joint corner of property now or formerly belonging to Wm. R. Timmons, Jr. and W. T. Patrick and Amos Tolbert) and running thence with the Western side of Ridge Road S 5-33 W 86.7 feet to a point; thence continuing with the Western side of Ridge Road S 7-35 W 434.1 feet to a point at the joint corner of the property herein being conveyed and property now or formerly belonging to Wm. R. Timmons, Jr. and W. T. Patrick; thence S 64-46 W 1019.5 feet to a point at the joint corner of the property herein being conveyed and property now or formerly belonging to Wm. R. Timmons, Jr. and W. T. Patrick; thence N 8-26 E 528.5 feet to a point at the joint corner of the property herein being conveyed and property now or formerly belonging to Wm. R. Timmons, Jr. and W. T. Patrick; thence N 64-47 E 1006.35 feet to a point on the Western side of Ridge Road at the point of beginning, 10 acres more or less.

Patrick died on August 24, 1976 and devised his interest therein to the grantor (see Apartment Number 1435, File Number 20, Probate Judge's Office for Greenville County).

THIS deed is executed subject to existing and recorded restrictions and rights of way, together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
