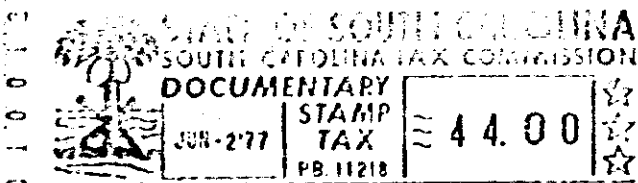
KNOW ALL MEN BY THESE PRESENTS, that James O. Sloan
