release unto **Henry C. Touard, Jr. and Brenda H. Touard, their heirs and assigns forever:**

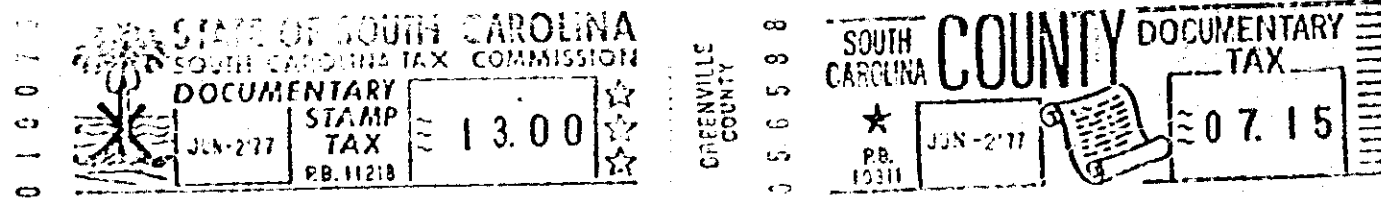
ALL that piece, parcel or lot of land in the County of Greenville,
