release unto **M. L. Lanford, Jr., his heirs and assigns forever:**

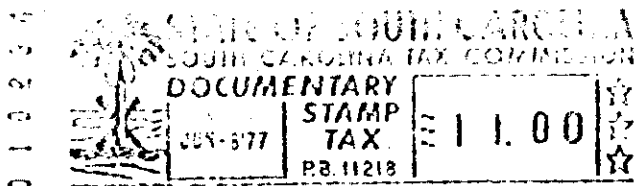
