in consideration of Ten Thousand and No/100 (\$10,000.00) Dollars, and assumption of the mortgages set out below, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Claude R. Rogers, his heirs and assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in the Town of Taylors, being known and designated as Lot No. 25 on a subdivision of Lot No. 2, Property of W. M. Shockley, deceased, as shown by subdivision and plat of same made by Thomas T. Linder, Surveyor, dated November 10, 1921, and recorded in Plat Book F, Page 45-b, RMC Office for Greenville County. This tract contains 6.55 acres and is more particularly described as follows:

BEGINNING at corner of Lot No. 26, at or near Edwards Street, and runs thence N. 77W. 5.70 chains to pine; thence N. 2-1/2 E. 6.97 chains to pin; thence N. 30-1/2 E. 5.09 chains to pin; thence S. 84 E. 4.02 chains to pin in or near Edwards Street; thence therewith S. 6-1/2 W. 12.25 chains to the point of beginning.

This conveyance is made subject to any rights of way or easements that may appear of record or on the premises, including that of Taylors Fire & Sewer District recorded in Deed Book 865, Page 205, RMC Office for Greenville County.

This being the same property conveyed to Judy B. Sprouse by deed of Claude R. Rogers, dated February 11, 1977, and recorded in the RMC Office for Greenville County, S.C. in Deed Book 1051 at Page 55 on February 15, 1977.

As a part of the consideration herein, the above-described property remains subject to that certain mortgage in favor of Southern Bleachery Baptist Church recorded in the RMC Office for Greenville County, S.C. in Mortgage Book 1375, page 915. Grantee herein assumes and agrees to pay the balance due on that certain mortgage given by grantor to grantee on February 11, 1977, recorded in the R.M.C. Office in Mtg. Book 1389 at Page 289.

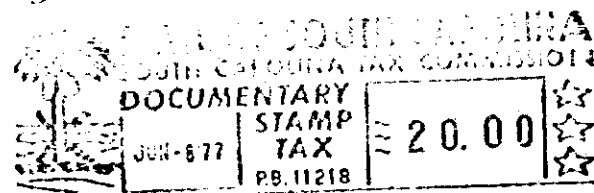
