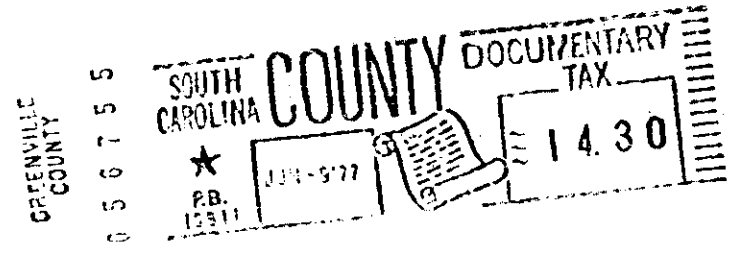
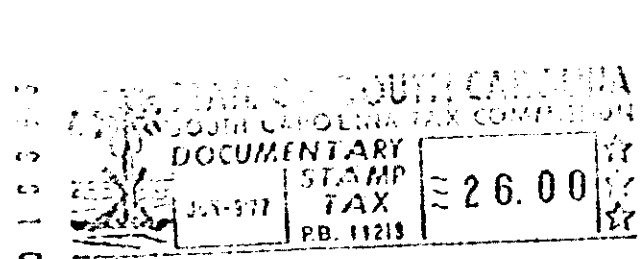
KNOW ALL MEN BY THESE PRESENTS, that HBA Properties, Incorporated
