in the state aforesaid, in consideration of the sum of Twenty-five Thousand Five Hundred and No/100 (\$25,500.00) Dollars-----

to US in hand paid at and before the sealing of these presents

by Billy E. Harvey and Linda C. Harvey

with force and effect, bargained, sold and released, and by Linda C. Harvey, their heirs and assigns, forever:

ALL that certain piece, parcel or lot of land located and being in Greenville County, State of South Carolina, containing 8.43 acres, more or less, as shown on a plat of W. J. Riddle, Surveyor, located in the RMC Office for Greenville County, South Carolina in Plat Book CC at page 96 and shown and designated thereon as Tract No. 2 and fronting along the northern side of a road as shown on said plat for a distance of 350 feet and having the courses and distances as upon said plat appear. Said property being bounded on the South by the aforementioned road, on the West by Tract No. 1 and lands of Beam, on the North by Tract No. 6 and lands of E. C. Rogers, branch intervening between Tract 2 and the Rogers lands and on the East by Tract No. 3 as shown on said plat.
