RMC Office for Greenville County, South Carolina.

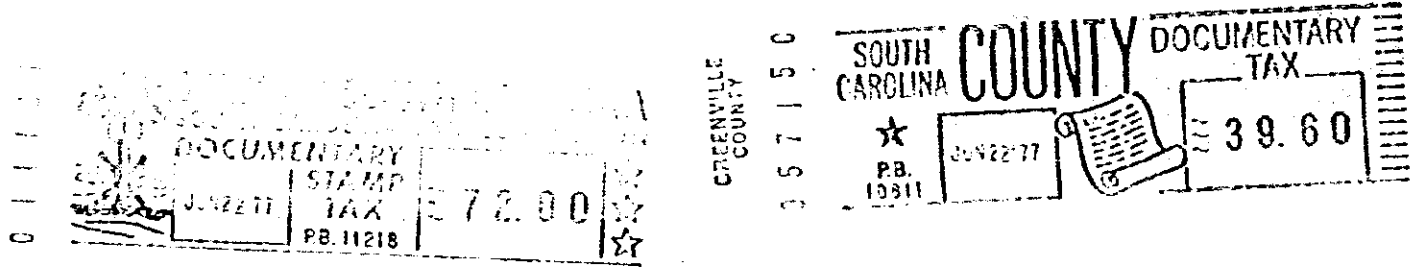
Reference to said plat is hereby craved for a more particular description.
