Known All Men by These Presents:

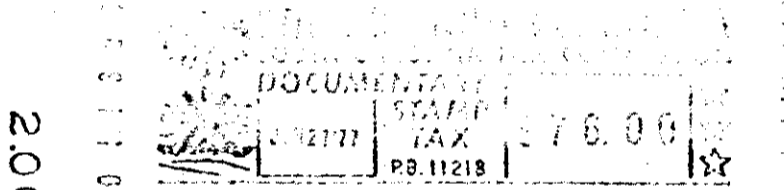
That Elisabeth Cauley Kennerly (formerly Elisabeth Cauley) hereafter referred to as Grantor, in consideration of the sum of Thirty-Eight Thousand and No/100 (\$38,000.00) DOLLARS, paid to Grantor by Robert Webster Anderson III and Nancy Shade Anderson hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantees, their heirs and assigns, forever:

ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot #139, Winding Way, Peppertree Subdivision, Section #2, as shown on a plat dated June 15, 1972, recorded in Plat Book 4R at Page 16, as revised by plat recorded in Plat Book 4X at Page 3, and having, according to said revised plat, the following metes and bounds, to-wit:

BEGINNING at a point located on the southern side of the right-of-way of Winding Way, a joint corner of Lots #139 and #140; thence S. 17-14 E. 150.0 feet to a point; thence S. 64-03 W. 60.5 feet to a point; thence N. 28-13 W. 155.0 feet to a point on said right-of-way; thence along said right-of-way N. 54-16 E. 15.0 feet to a point; thence N. 71-12 E. 70.0 feet to the point of beginning.

The above property is subject to the Amended Declaration of Covenants, Conditions and Restrictions recorded in the Office of the R.M.C. for Greenville County in Deed Book 978 at Page 895, and to any other restrictions, easements and rights-of-way of record, including a five foot drainage and utility easement along side and rear lot lines.

This is the same property conveyed to the grantor by deed of Brent Corporation, dated August 13, 1973, and recorded on August 15, 1973, in the Office of the RMC for Greenville County, South Carolina in Deed Book 981 at Page 625.
