KNOW ALL MEN BY THESE PRESENTS that Holly Tree Plantation, in consideration of the premises and covenants and one dollar paid does grant unto the Laurens Electric Cooperative, Inc., and its successors and assigns the right to enter upon the lands of the undersigned as hereinafter described in the County of GREENVILLE and State of South Carolina, and to place, construct, operate, maintain, repair and replace in the areas designated on the attached drawing all necessary underground electric transmission, distribution and service lines and related equipment to provide electric service to the areas as shown,

The Cooperative shall have the right to clear and keep cleared all brush and trees along said right of way sufficient to install and repair and maintain such buried lines, and owner will not construct or plant any obstruction to prevent such installation and maintenance. The Cooperative shall construct and install such facilities in accordance with applicable codes and approved construction practices, and owners and their assigns will not permit any grading or excavation in these areas without arranging with the Cooperative in advance of such work.

This right of way and easement shall continue and run with the land so long as same is used or needed and shall be binding upon both the grantor and grantee and their heirs, successors and assigns. The grantor herein covenants it is owner in fee of this property and has legal right to grant this easement and right of way. The lands over which easement and right of way is granted are as follows:

A tract of land in GREENVILLE County, S.C. on BETHEL road about 2 miles from Town of PIMPSONVILLE, bounded by lands of Holly Tree Plantation

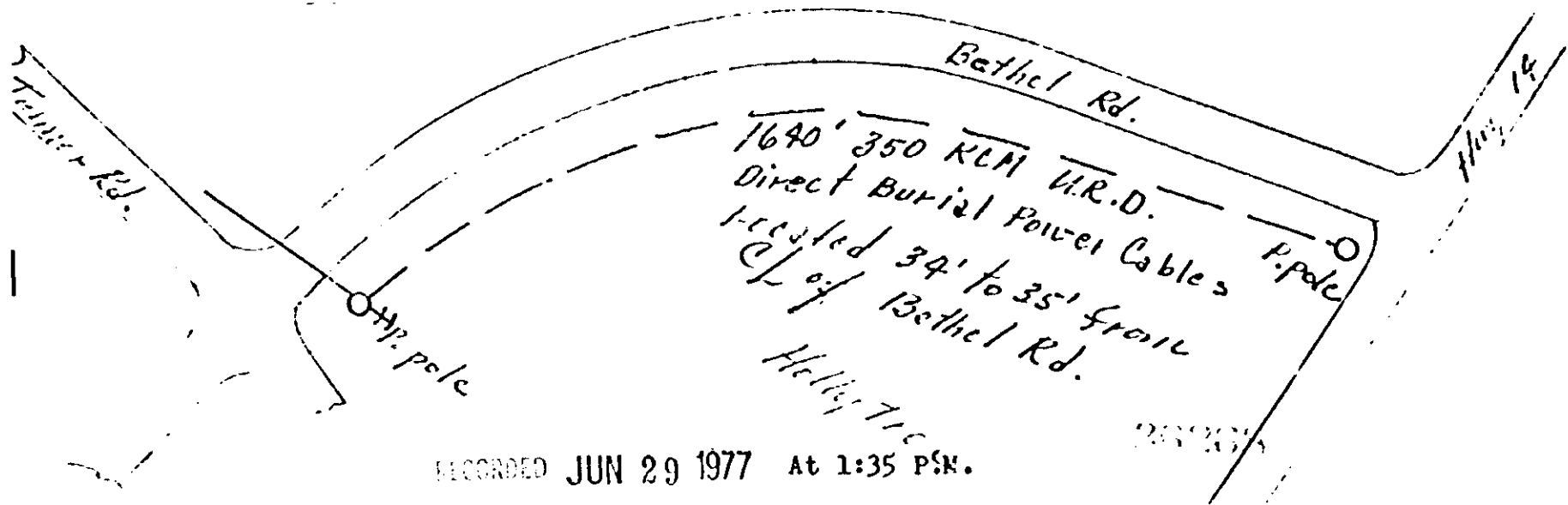
