William Lea Halbert and Marlene W. Halbert, their heirs and assigns, forever:

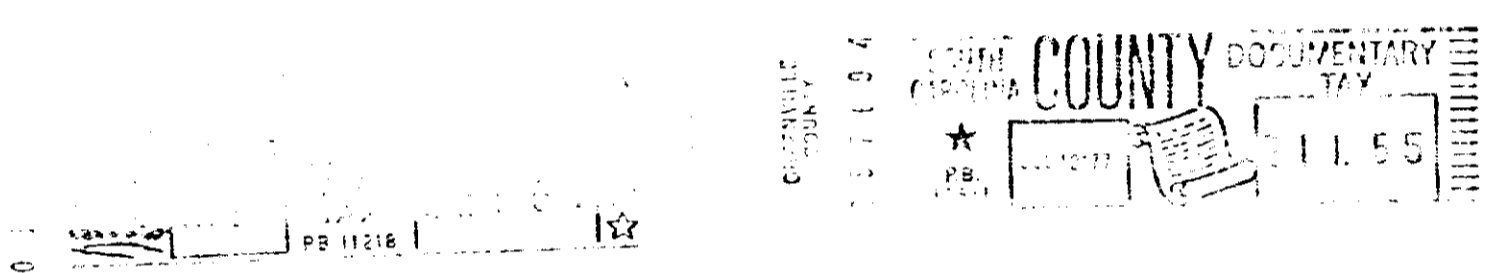
