ALL my right, title and interest in and to all that piece, parcel or lot of land
in Chick Springs Township, Greenville County, State of South Carolina, on the Worley
Road (erroneously called Chick Springs Road) sometime being a portion of Tract No. (4)
of the property of J. C. Hall as shown on plat of R. E. Dalton, C. E., made in December
of 1916, and having the following metes and bounds, as shown on said plat:
