unto Rosamond Enterprises, Inc., its successors and assigns, forever:

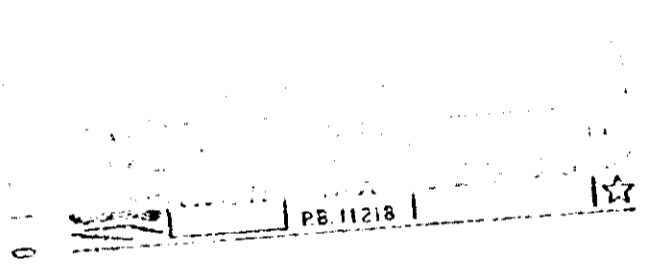
ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina,
