Foster and Donna L. Foster, their Heirs and Assigns, forever:

ALL that certain piece, parcel, or lot of land, situate, lying, and being in the County of Greenville, City of Greenville, State of South Carolina, and being known and designated as Lot 100 of Vista Hills Subdivision, according to a plat prepared of said subdivision by Dalton & Neves, Surveyors, May, 1946, and the plat of which said Subdivision is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book P, at Page 149, and according to said plat, having the following courses and distances, to-wit:

BEGINNING at a point on the edge of Ashford Avenue, joint corner of Lots 99 and 100 and running thence with the common line with Lot 99, N. 70-28 W. 163.6 feet to a point in or near the center of an alley; thence, S. 18-32 W. 75 feet to a point in or near the center of said alley; thence, S. 70-28 E. 164.3 feet to a point on the edge of Ashford Avenue; thence running with said Avenue, N. 19-32 E. 75 feet to a point on the edge of said Avenue, the point of Beginning.

The within property is conveyed subject to all easements, rights-of-way, protective covenants and zoning ordinances.

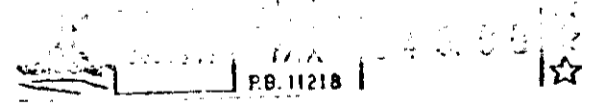
