the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell
and release unto

Ellen C. Batchelder, her heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 88 of a subdivision known as Pebble Creek, Phase I as shown on plat thereof prepared by Enwright Associates, Engineers, dated October 1973, and recorded in the R.M.C. Office for Greenville County in Plat Book 5-D at Page 2 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Sassafras Drive, joint front corner of Lots 87 and 88, and running thence along the southeastern side of Sassafras Drive, N. 53-12 E. 46.86 feet to an iron pin; thence continuing along the southeastern side of Sassafras Drive, following the curvature thereof, the chord being N. 47-59 E. 50.0 feet, to an iron pin at a corner of Lot 89; thence along the line of that lot, S. 45-35 E. 251.6 feet to an iron pin on Fairway No. 11; thence along the line of Fairway No. 11, S. 47-48 W. 137.35 feet to an iron pin at a rear corner of Lot 87; thence along the line of that lot, N. 36-26 W. 257.0 feet to the beginning corner.

This conveyance is subject to restrictions and covenants recorded in the R.M.C. Office for Greenville County in Deed Vol. 991 at Page 10 as well as any other restrictions, rights-of-way or easements that appear of record, on the plat referred to above or as shown on the premises.
