TITLE TO REAL ESTATE

Know All Men by These Presents:

That Harbor Town Limited Partnership, a S. C. Limited Partnership, hereafter referred to as Grantor, in consideration of the sum of Twenty-five Thousand Five Hundred and no/100 DOLLARS, paid to Grantor by Scotty L. Stone, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, his heirs and assigns forever:

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 28 on plat of Harbor Town, recorded in the R.M.C. Office for Greenville County in Plat Book 5P, at Pages 13 and 14, and being more particularly described as follows:

BEGINNING at a point at the joint corner of Units 28 and 29 and thence running S 39-57 W, 21.6 feet; thence turning and running N 50-03 W, 68.6 feet; thence turning and running N 39-57 E, 21.6 feet; thence turning and running S 50-03 E, 68.6 feet to the point of BEGINNING.

This is a part of the property conveyed to grantor by Carla A. Hills, Secretary of Housing and Urban Development by deed dated April 11, 1975 and recorded April 14, 1975, in the R.M.C. Office for Greenville County in Deed Book 1016 at Page 729.

The foregoing conveyance is subject to the terms of that Declaration of Covenants, Conditions and Restrictions, executed by Harbor Town Limited Partnership on January 26, 1976, and recorded in the R.M.C. Office for Greenville County, S. C., on February 6, 1976, in Deed Book 1031, at Page 271.

Grantor hereby agrees to pay 1977 Greenville County property taxes.

AND Grantor does hereby bind Grantor and Grantor's Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto Grantee and Grantee's Heirs/Successors and Assigns against Grantor and Grantor's Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
