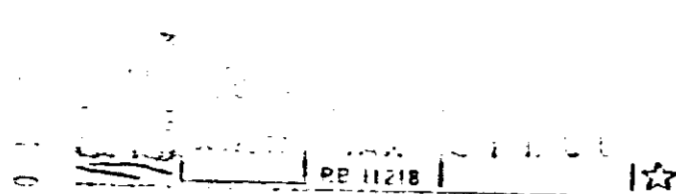

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Douglas F. Rall and Naomi D. Rall, their heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being on the Southern side of Regent Drive, in Paris Mountain Township, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 47 of a subdivision known as Edgefield and having, according to a plat of said subdivision, prepared by Piedmont Engineering Service, dated March, 1957, and revised September, 1957, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book NN at page 195, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Regent Drive at the joint front corner of Lots Nos. 48 and 47 and running thence with the line of Lot No. 48 S. 25-11 W. 212.3 feet to an iron pin at the joint rear corner of Lots Nos. 47 and 51; thence with the line of Lot No. 51 N. 49-05 W. 198.9 feet to an iron pin on the Southern side of Regent Drive; thence with the curve of the Southern side of Regent Drive, the chords of which are as follows: N. 47-58 E. 54.4 feet to an iron pin, thence N. 62-20 E. 75 feet to an iron pin, thence N. 87-24 E. 75 feet to an iron pin, and thence S. 77-52 E. 60 feet to the point of beginning.

This conveyance is made subject to "Protective Covenants Applicable to Edgefield", recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 576 at page 149; to "Amendment to Protective Covenants Applicable to Edgefield", recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 587 at page 178; and to drainage and utility easements including water lines shown on the aforesaid plat.

This deed is executed pursuant to resolutions passed by the Board of Directors of Furman University, October 30, 1956, and by The Executive Committee of the Board of Trustees, June 25, 1957, which resolutions authorize either the President or the Treasurer of the University to execute deeds conveying lots in Edgefield Subdivision.
