Know All Men by These Presents:
That Harbor Town Limited Partnership, a S.C. Limited Partnership hereafter referred to as Grantor, in consideration of the sum of Twenty-six Thousand Four Hundred Fifty DOLLARS, paid to Grantor by Elinor D. Carter hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, her heirs and assigns forever:

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Lot 96 on plat of Harbor Town recorded in the RMC Office for Greenville County in Plat Book 5P at pages 13 and 14 and being more particularly described as follows:

BEGINNING at a point at the corner of Units 96 and 97 and then running S 71-30 W, 21.6 feet; thence turning and running N 18-30 W, 68.7 feet; thence turning and running N 71-30 E, 21.6 feet; thence turning and running S 18-30 E, 68.7 feet to the point of BEGINNING.

This is a part of the property conveyed to grantor by Carla A. Hills, Secretary of Housing and Urban Development, by deed dated April 11, 1975 and recorded April 14, 1975 in the RMC Office for Greenville County in Deed Book 1016 at Page 729.

The foregoing conveyance is subject to the terms of that Declaration of Covenants, Conditions and Restrictions, executed by Harbor Town Limited Partnership on January 26, 1976 and recorded in the RMC Office for Greenville County, S. C. on February 6, 1976 in Deed Book 1031 at page 271.

Grantor hereby agrees to pay 1977 Greenville County property taxes.

AND Grantor does hereby bind Grantor and Grantor's Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto Grantee and Grantee's Heirs/Successors and Assigns against Grantor and Grantor's Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
