the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell  
and release unto CYNTHIA R. LEE, her heirs and assigns forever:

All that lot of land with improvements situate, lying and being on the Eastern side of York Drive (formerly known as Blythewood Drive) in Greenville County, South Carolina, being shown as the Southern portion of Lot No. 100 on Map 2 of Camilla Park, made by W. J. Riddle, Surveyor, dated December, 1943, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book M, Page 85, and having according to a more recent survey made by Campbell & Clarkson Surveyors, Inc., dated October 1969, the following metes and bounds, to-wit:

Beginning at an iron pin on the Eastern side of York Drive at the joint front corners of Lots Nos. 99 and 100, and running thence N.84-15E., 98.5 feet to an iron pin; thence along the rear lot line of Lot No. 104, N.9-28W. 80.6 feet to an iron pin; thence a line through Lot No. 100, S.72-35W. 108.9 feet to an iron pin on York Drive; thence along the Eastern side of York Drive, S.19E. 60 feet to an iron pin, the beginning corner.

Being the same property conveyed to the Grantor by deed in Deed Book 1028, at page 701 recorded in the R. M. C. Office for Greenville County, South Carolina, Katherine N. Stack, December 15, 1975.

Subject to all covenants, restrictions, reservations, easements, conditions and rights appearing of record; and subject to any state of facts an accurate survey would show.

As a part of the consideration for this conveyance the Grantees expressly assumes and agrees to pay the balance due on a certain note and mortgage in the favor of the Federal National Mortgage Association and recorded in the R. M. C. Office for Greenville County in Mortgage Book 1327, at page 681, with a principal balance of \$10,227.15.
