the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Arthur T. Lambrecht, his heirs and assigns, forever:

ALL that certain piece, parcel or lot of land located in the County of Greenville, State of South Carolina, and lying on the southeastern side of Rollinggreen Road and being known and designated as Lot 269 according to a plat of Botany Woods, Sector V, a plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book YY at Pages 6 and 7, and being more particularly described according to a plat entitled "Property of Kit P. Tomlin and Laura H. Tomlin by Freeland Associates, dated October 29, 1975, and having, according to said plat, the following metes and bounds, to-wit:
