In consideration of Fifteen Thousand Five Hundred and No/100 (\$15,500.00)-----Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JOHN C. DREISBACH AND NANCY H. DREISBACH, their heirs and assigns forever,

ALL that piece, parcel or lot of land situate, lying and being in Paris Mountain Township, near Paris School, being known and designated as Lot No. 11, according to plat of E.H. Green property recorded in the R.M.C. Office for Greenville County in plat book I pages 9 & 10, and described as follows:

BEGINNING at an iron pin on the west side of Nature Trail (formerly Green Street), the corner of Lot 10, and running thence with the line of lot 10, N. 70-30 W. 500.9 feet to an iron pin; thence S. 26-30 W. 100.75 feet to an iron pin in line of Lot 12; thence with the line of Lot 12, S. 70-30 E. 512.5 feet to an iron pin on Nature Trail (formerly Green Street), and running thence with the west side of said street N. 19-30 E. 100 feet to the beginning point.

THIS is the same land conveyed to the grantors William G. McCall and Etta B. McCall by deed recorded July 7, 1970 in Deed Book 893 at Page 451 of the R.M.C. Office for Greenville County, S.C. and is conveyed subject to any recorded restrictions, easements or rights of way.
