the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Samuel Boyce Thomason, his heirs and assigns, forever, an undivided 45% interest in and to the following described real estate:

ALL that piece, parcel or tract of land situate, lying and being on the western side of Miller Road near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as a major portion of Tract No. 4 and a small portion of Tract No. 3 on a plat of property prepared by C. O. Riddle, July, 1966, entitled Estate of Mary Pack Miller, which plat is recorded in the R.M.C. Office of Greenville County in Plat Book PPP at page 33, and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Miller Road at the joint front corner of Tracts Nos. 4 and 5 and running thence with the joint line of said tracts N. 66-38 W. 629.7 feet to an iron pin in the line of property of Fiber Industries, running thence with that line N. 11-42 E. 409.15 feet to an iron pin, running thence S. 78-57 E. 228 feet to an iron pin, running thence N. 53-05 E. 266.5 feet to an iron pin in the rear lot line of Tract No. 2, running thence S. 21-24 W. 230 feet to an iron pin, the rear corner of Tract No. 2, running thence with the line of Tract 2 S. 67-17 E. 368.6 feet to an iron pin on the western side of Miller Road, running thence with the western side of said Road, S. 28-57 W. 373.7 feet to an iron pin, thence continuing with said Road, S. 26-44 W. 126.3 feet to an iron pin, point of beginning.
