in consideration of Thirty Thousand Five Hundred and No/100-----(\$30,500.00)-----Dollars,

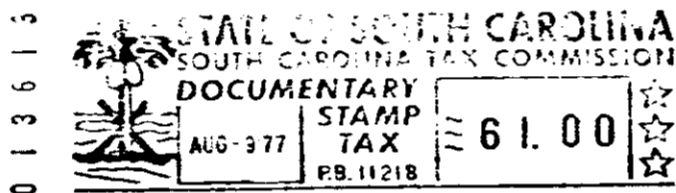
