BEGINNING at a point, said point being approximately 633 feet in a southeasterly direction from a curve in Griffith Road (said curve being in a southeasterly direction from Congaree Road) and on the center line of a Duke Power Company 74 foot right of way and running thence S. 43 E., 219.7 feet to an iron pin at a branch, thence along said branch N. 48 E., 189.7 feet to an iron pin on the southwestern edge of line of the right of way of Highway I-385, thence along the southwestern edge of the right of way of said highway the following courses and distances, N. 33-05 W., 92 feet to an iron pin; N. 27-45 W., 86.1 feet to an iron pin; N. 31-25 W., 94.5 feet to an iron pin on the center line of the Duke Power Company 74 foot right of way; turning and running thence S. 40-15 W., 239.5 feet with the center line of said right of way to the point of beginning.

This conveyance is made subject to all easements, conditions, covenants, restrictions and rights of way which are a matter of record and/or actually existing on the ground affecting the above described property.
