to said plat, having the following metes and bounds, to wit:

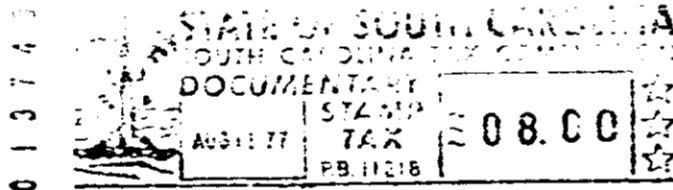
BEGINNING at an iron pin on the western side of Carolina Way, joint corner Lots 10 and 11
