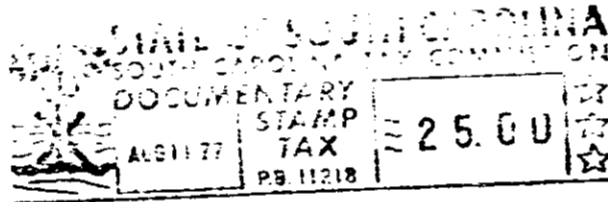
THE CLARENDON CLUB, INC., its Successors and Assigns, forever;
