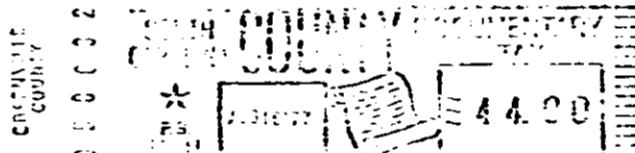
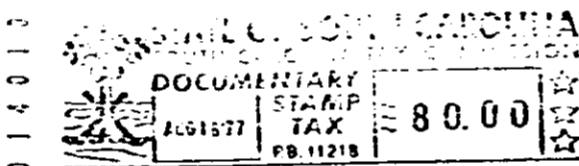

J. Riddle, dated October, 1936, said plat being recorded in the RMC Office of the Greenville County Courthouse in Plat Book K at Page 122 and more recently shown on plat of property of Richard D. Wooten, prepared by Campbell and Clarkson, Surveyors, dated August 17, 1973 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING At an iron pin on the southern side of Hillcrest Drive, said pin being located approximately 606 feet from the intersection of Hillcrest Drive and North Main Street and running thence S. 23-30 W. 189.7 feet to an iron pin on the northern side of a 10-foot alley; thence running along and with said alley, N. 66-30 W. 71 feet to an iron pin; thence running N. 23-30 E. 189.7 feet to an iron pin on the southern side of Hillcrest Drive; thence running along and with Hillcrest Drive, S. 66-30 E. 71 feet to the beginning point.

This conveyance is subject to any and all existing reservations, easements, rights-of-ways, zoning ordinances and restrictions or protective covenants that may appear of record or on the premises.
