Scott, a 1/2 undivided interest, the following described property:

ALL that certain piece, parcel or lot of land situate, lying and being on the southeastern side of Memorial Medical Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 5 as shown on plat entitled Memorial Medical Park, dated May 23, 1977, prepared by W. S. 34-22 W. 150 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence with the line of Lot No. 6 N. 42-46 W. 270.9 feet to an iron pin on the southeastern side of Memorial Medical Drive at the joint front corner of Lots Nos. 5 and 6; thence with the southeastern side of Memorial Medical Drive the following courses and distances: N. 74-35 E. 64.3 feet to an iron pin; N. 65-00 E. 60 feet to the point of BEGINNING.
