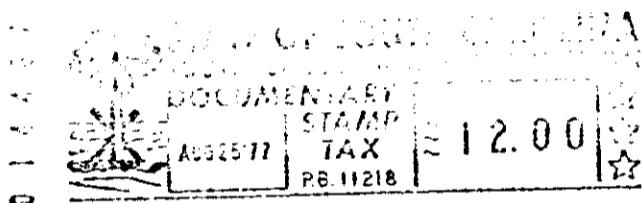
KNOW ALL MEN BY THESE PRESENTS, that Williams Builders, Inc.
