to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Thomas E. Ross, for and during the term of his natural life and the remainder upon his death to Terry E. Ross, Cathy E. Ross, their heirs and assigns forever:

ALL those pieces, parcels or lots of land situate, lying and being in Greenville County, South Carolina being known as Lots 8 and 9, fronting on Sixth Street in Conestee, as depicted on plat of survey by Madison H. Woodward, Surveyor entitled "Conestee Plat 3", recorded in Plat Book Y at Page 121 in the R.M.C. Office for Greenville County and being more fully described as follows: BEGINNING at the joint corner of Lots 10 and 9 and running thence with Sixth Street, N 42-14 E.; 120 feet to the joint corner of Lots 7 and 8; thence turning and running with the line of Lot 7, N. 47-46W., 200.2 feet to the joint corner(rear) of Lots 7 and 8; thence along the line of Lots 83 and 84, S. 42-18 W. 120 feet to the joint rear corner of Lots 9 and 10; thence along the line of Lot 10, S. 47-46 E., 200.4 feet to the point of beginning.

This Conveyance is made subject to all easements, conditions, covenants restrictions and rights of way which are a matter of record and/or actually existing on the ground affecting the above described property.

This is the same property to the Grantor herein by deed of Madison A. Goldsmith and Henry P. Williams recorded in the R.M.C. Office for Greenville County February 2, 1976 in Deed Book 1031 at Page 23.

The grantee assumes and agrees to pay Greenville County property taxes for the year 1978 and all subsequent years.

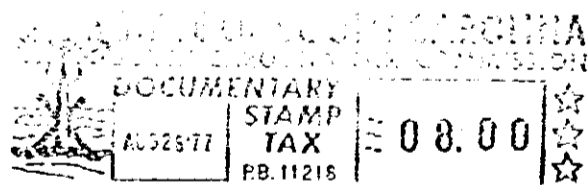
