ROY S. LEWIS AND TONA MARIE LEWIS, their heirs and assigns, forever:

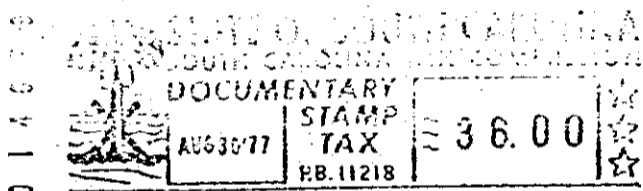
