ALL that certain lot or parcel of land containing 9.6 acres, more or less, and being situate on Bird Mountain Ridge approximately three miles south of Tryon, North Carolina, in Glassy Mountain Township, Greenville County, South Carolina, and being more specifically shown and described as LOT NO. 5 on a plat of a survey for Alan T. Calhoun by W. N. Willis, Engineers, dated April 6, 1972, recorded in Plat Book 4-T at page 14 in the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:
