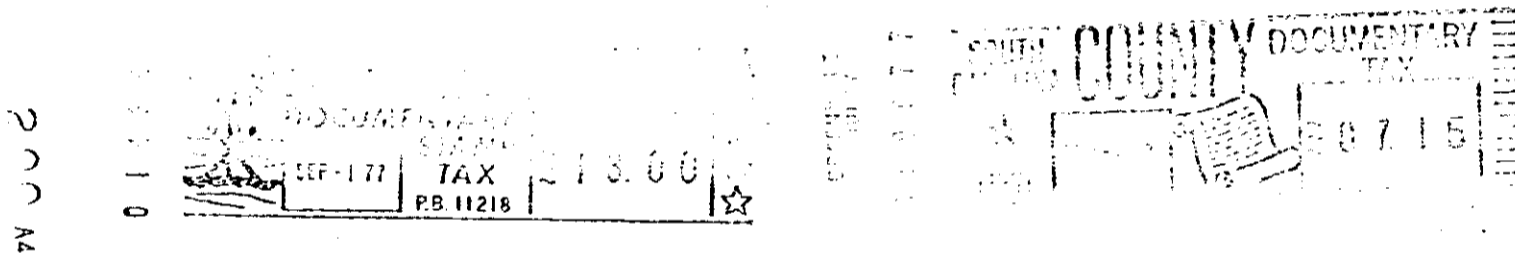

ALL that certain parcel or tract of land situate, lying and being in The State of South Carolina, County of Greenville, about one (1) mile west of Gowansville, on the east side of an un-named county road, approximately 1100 feet northeast of the intersection of Lee Road and State Highway No. 11 being shown and designated as Tract No. 8, containing 5.3 acres, on a plat of property prepared for Harold Smith by W. N. Willis, Surveyor, dated March 2, 1973, and, according to said plat having the following metes and bounds:

BEGINNING at a point in the center of said un-named county road, joint front corner of Tracts Nos 8 and 9, and running thence as dividing line between said tracts, S. 64-30 E. 485 feet to an iron pin on line of, now or formerly, Toe Greene; thence with the line of Greene, S. 35-00 W. 488 feet to an iron pin, rear corner of Tract No. 7; thence with the line of Tract No. 7, N. 64-30 W. 570 feet to a point in the center of said un-named county road; thence thencewith, N. 43-00 E. 500 feet to the point of beginning.
