release unto **ROSAMOND ENTERPRISES, INC.,** its successors and assigns forever:

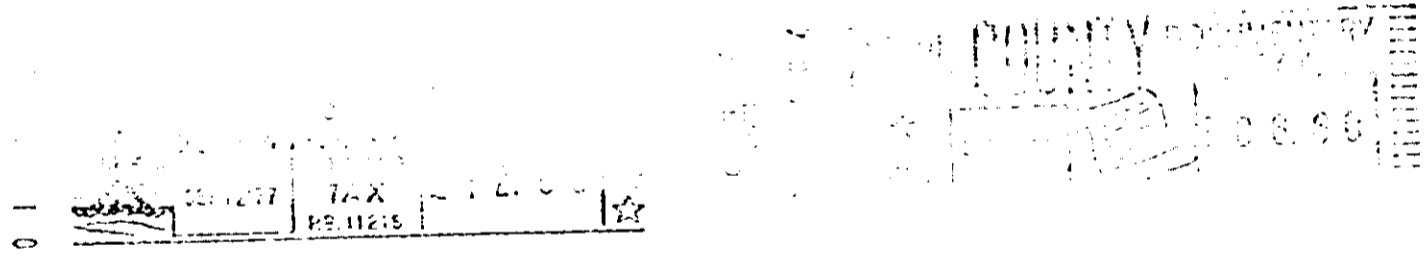
ALL that piece, parcel or lot of land in the County of Greenville,
