ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 3 on Plat of Aberdeen Highlands, plat of which is recorded in the RMC Office for Greenville County, S. C. in Plat Book M, at Page 37, and having according to said plat, the following metes and bounds, to-wit:
