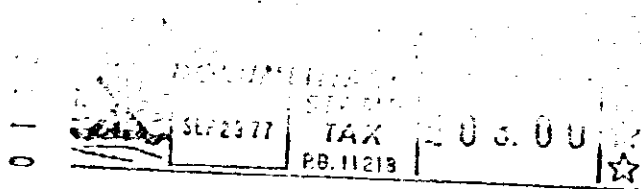
TOMMY B. WESSINGER AND BARBARA B. WESSINGER, THEIR HEIRS AND ASSIGNS FOREVER:
