Fuman Cooper, his heirs and assigns, forever:

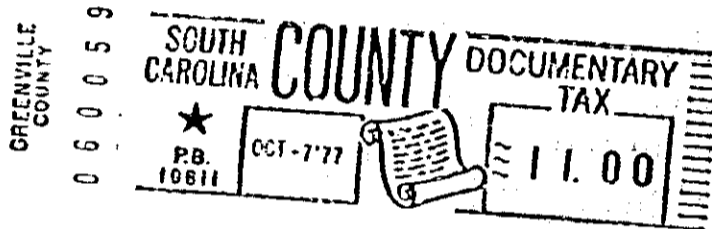
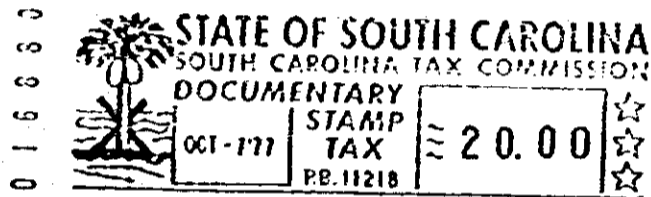
