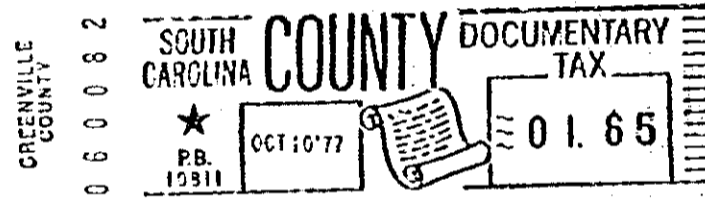
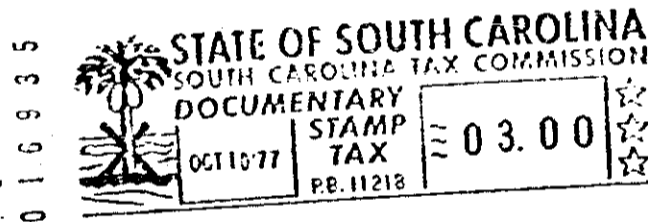

BEGINNING at a point on the western side of Motor Boat Club Drive at the corner of Lot No. 23, and running thence with the line of said lot, N. 79-47 W., 302.7 feet to a point; thence N. 39-58 W., 79.52 feet to a point at the joint rear corners of Lots Nos. 24 and 25; thence with the common line of said lots, N. 70-16 E., 279.7 feet to a point on Motor Boat Club Drive; thence with the western side of said drive, S. 25-50 E., 101.3 feet to a point; thence continuing with said side of said drive, S. 19-25 E., 125 feet to the point of BEGINNING.
