HAROLD L. HINTON AND JANICE G. HINTON, their heirs & assigns forever:

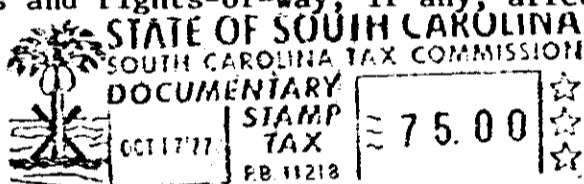

B. Peden (Remainder Lot 13) and running thence with the line of said property S. 67-00 E. 242.4 feet to an old iron pin in the line of property of Maude B. and David A. Henderson; running thence with the line of said property N. 3-15 W. 288.9 feet to a nail and cap in the center of Fairview Church Road (S-451); running thence with the center of said road N. 82-36 W. 115.5 feet to the point of beginning.
