 sell and release unto James C. Kincannon, his heirs and assigns forever:

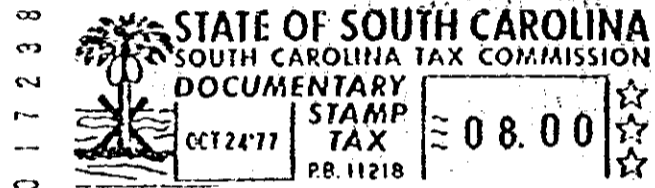
ALL that certain piece, parcel or tract of land, located, lying and being in the State of South

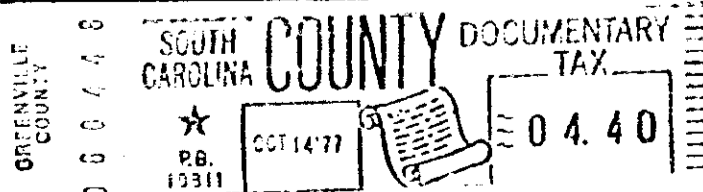
RENUNCIATION OF DOWER
