ALL water lines, mains, valves and appurtenances installed and located in, under or along Roper Mountain Road and Farrell Kirk Lane, County of Greenville, State of South Carolina, including approximately 815 feet, more or less, of 6" C. I. pipe; 410 feet, more or less, of 2" galvanized pipe; 2 - 6" valves to open right; 2 - 2" valves to open left; and 1 fire hydrant, to be 3-way and open right, and is shown on a drawing entitled "Hollyton, Inc. to Commissioners of Public Works of the City of Greenville, S. C." dated October 21, 1977, attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to said lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.
