the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

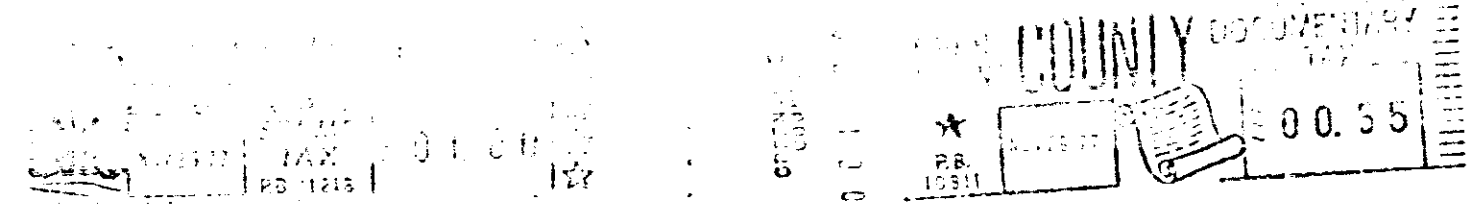
Milton T. Smith, his heirs and assigns, forever, all my undivided right, title and interest in and to the following described property:
