OOD PER CORD OR 1.38 PER TON OF HARDWOOD AND 1.50 PER TON OF PINE. SAID TIMBER IS THAT WHICH IS GROWING DEAD THE RIVER BANK.

Said timber now being, standing and growing upon the following described lands, situated in the County of GREENVILLE and State of South (PROLINA):

THE AFOREMENTIONED PROPERTY IS LOCATED NORTH OF MARIETTA ALONG RIVER ROAD AND IS DESCRIBED IN A CERTAIN DEED RECORDED IN DEED BOOK 820, PAGE 629, GREENVILLE COUNTY REGISTRY

Together with the right of ingress, egress, and regress, for Grantee, its successors and assigns and their agents, servants, contractors and employees, over and across said lands, and any other lands of Grantor(s) for the purpose of cutting, removing and manufacturing said timber, and the right to install on said lands machinery, equipment and structures useful, necessary or convenient in the business of logging, sawing and removing said timber, together with the right to remove the same.
