BEGINNING at an iron pin on the south side of said road at joint corner with property formerly known as Negro Church property; thence with said Church property, S. 11-45 N. 120 feet to the joint corner of property formerly owned by J. A. Burns; thence N. 59-30 E. 60 feet, more or less, to the center of Gentry Street; thence along said street in a southwest direction about 100 feet to an iron pin; thence S. 71-45 W. 76 feet to an iron pin; thence N. 11-45 W. 225 feet to a stake on Bramlett Road; thence N. 71-15 E. 75 feet to the beginning corner.

Also, all that piece, parcel or lot of land in Greenville County, State of South Carolina, on new cut road, and having metes and bounds, as follows:

BEGINNING one hundred feet from a pipe on new cut road; thence S. 11-45 E. 35 feet to a stake; thence S. 59-30 W. crossing road 72 feet to a pipe; thence N. 11-45 W. 35 feet to a stake; thence N. 59-30 E. 72 feet crossing road to a stake, the beginning corner, and being Lot No. 1, less the road, as shown by plat of R.
