(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents

do grant, bargain, sell and release unto the said COTHRAN & DARBY BUILDERS, INC., its successors and assigns forever:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Grey Stone Court near the City of Greenville, South Carolina, being known and designated as Lot No. 218 on plat entitled "Revised Plat, Lots 217 and 218, Map No. 2, Section 1, Sugar Creek" as recorded in the RMC Office for Greenville County, South Carolina in Plat Book 6G at page 41 and having, according to said plat, the following metes and bounds, to wit:
