 release unto PETER J. O'KEEFE and MARGARET M. O'KEEFE, their heirs and assigns, forever:

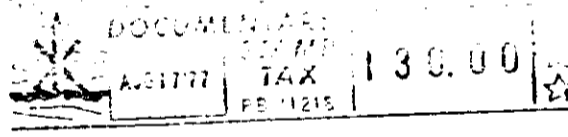
ALL that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the northerly side of White Water Court, near the City of Greenville, South Carolina, and being designated as Lot 169, Map No. 2, Section I, Sugar Creek, as recorded in Plat Book 4R, page 85 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of White Water Court, joint front corner of Lots 168 and 169 and running thence along the common line of said lots N. 25-04-38 W. 154.07 feet to an iron pin; thence S. 77-52-44 W. 55.26 feet to an iron pin; thence S. 82-24-19 E. 125.74 feet to an iron pin; thence along the common line of said lots S. 27-09-46 E. 152.23 feet to an iron pin on the northerly side of White Water Court; thence on a curve the chord of which is S. 41-24-35 E. 35.36 feet to an iron pin; thence continuing with said Court N. 64-55-22 E. 64.95 feet to an iron pin, the point of beginning.

This is a portion of the same property conveyed to the grantor herein by deed of M. Graham Proffitt, III, Ellis L. Darby, Jr. and John Cothran Company, Inc. recorded December 9, 1976, in Deed Book 1047, page 620.

This deed is subject to a 25' sewer easement as shown on said plat, and is subject to all restrictions, setback lines, roadways, rights of ways, if any, affecting the above described property. This deed rerecorded as the call inserted above was by oversight omitted when deed originally drawn.
