in consideration of Thirty-two Thousand Nine Hundred Fifty and no/100 (\$32,950.00) ----- Dollars,

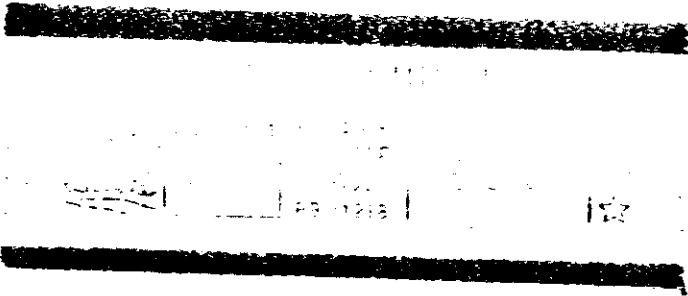
