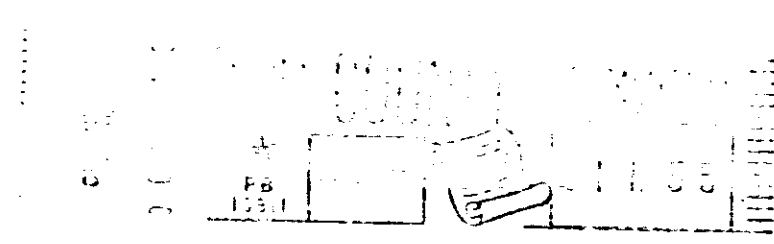
KNOW ALL MEN BY THESE PRESENTS, that W. D. Yarborough
